- We have reviewed the accompanying statement of unaudited financial results of Eastern Logica Infoway Ltd. NOTES TO THE UNAUDITED FINANCIAL RESULTS FOR THE HALF YEAR ENDED SEPTEMBER 30, 2023

- The above financial results of the company have been prepared in accordance with Accounting Standard ("AS") as
 prescribed under Section 133 of the Companies Act, 2013 ("the Act") read with rule 7 of the Companies (Accounts)
 Rules, 2014 and relevant rules amended thereafter and in terms of Regulation 33 of SEBI (Listing Obligations and
 Disclosure Requirements) 2015, as amended. The financial results of the company have been reviewed by the Audit
 committee and approved by the Board of Directors at their meeting held on November 14, 2023. The above results
 has also been subjected to limited review by statutory auditors of the company.
- 2. As per the MCA notification dated 16th February 2015, companies whose shares are listed on SME Exchanges as referred to in Chapter XB of SEBI (Issue of Capital and Disclosure Requirements) Regulation 2009, are exempted from the compulsory requirements of adoption of Indian Accounting Standards ("Ind AS").
- The Company is primarily engaged in trading in Computers, Laptops, Mobiles, Computers Parts, & Accessories etc. Accordingly, there are no separate reportable segments as per AS 17 "Segment Reporting"
- 4. With a view to conserving resources, the Board of Directors do not propose to recommend payment of any Dividend for the year under review.
- 5. Figures of the half year ended March 31, 2023 are the balancing figures between audited figures for the full financial year and the unpublished year to date figures upto the half year of that financial year. The figures for half year ended September 30, 2022 have been prepared by the management by excersing the necessary due diligence that financial results for this perioud provide a true and fair view of company affairs.
- 6. Earning per share for the half year ended September 30, 2023, March 31, 2023 and September 30, 2022 has been calculated for half year respectively and not annualised.
- 7. The previous period figures have been re-grouped / reclassified and EPS restated, wherever considered necessary.
